## 1) Give a brief account of your O. A. story:

I came into OA in June of 1882 and attended my first OA meeting. I thought the women that were in the meeting were crazy and I was sane. I did not return to OA until January 7, 1983. That meeting was to change my life forever. I got abstinence two weeks later and lost 90 lbs. the first nine months of working the program. In late August of that same year, I had many compliments on my weight loss and my head was not were it should have been. I still felt fat and not ready to handle all of the sexual attraction and feelings that I was feeling. I choose to eat something that was not on my food plan because I was used to hiding what I was feeling and thinking at the time. My decision to take that first bite lead me to start my first relapse in this program. Dealing with my feelings about my body image was not always easy to deal with since I have used food to find comfort from what I was really feeling. My current abstinence is one that I treasure very much being a person who has experienced relapse several times throughout my OA life. I am working through my issues and will continue to deal with them as I continue to work this program. I have a sponsor and have several people who I am sponsoring at this time.
